The undersigned further agrees to return all of the equipment no later than the return date specified above and in its present condition, ordinary wear and tear excepted, the undersigned shall reimburse NEADS 2, INC., the replacement cost for said equipment.

I am aware that outdoor recreational activities can be hazardous and I, the undersigned, agree to indemnify and hold harmless NEADS 2, INC., from all claims, demands and causes of actions against NEADS 2, INC., by any person, for any loss or injury to persons or property arising out of aforescribed equipment or in reliance upon advice of officers, employees or agents of NEADS 2, INC.
